

DRAFT MINUTES OF THE IADSA ANNUAL GENERAL MEETING HELD ON 11 June 2020 from 13.00 to 14.45 BST

Welcome and introduction

- The meeting was called to order at 13:00 BST under the chairmanship of Michelle Stout.
- The antitrust statement was read out: "Although it is appropriate to discuss matters
 dealing with government policies and regulations concerning ethical and scientific
 issues involving food supplements, we should not discuss an individual member's
 specific products, prices, sales, marketing or pricing activities or plans which could
 affect competition between companies in the food supplement business".

Composition of the meeting and procedures

- The Annual General Meeting (AGM) was validly convened and the required quorum (in conformity with article 34.1 of the IADSA Articles of Association) for deliberation regarding the items listed on the agenda was met.
- The Chair opened the meeting by welcoming members.
- As the AGM was being conducted remotely, it was explained that there would be some differences in how the meeting would be conducted. The subject matter would include the same issues as were typically covered at each Annual General Meeting.
- For the Resolutions to be considered, the General Assembly would be asked whether any member has an objection. If no objection would be raised, the Resolutions would be adopted.
- The Board elections will be carried out by electronic vote via ElectionBuddy after the
 end of the administrative session. The process would be explained in detail later in the
 meeting.
- The results of the elections would be announced by email to the membership.



- The AGM would officially end with the closure of the last voting round.
- Finally, it was emphasised that members could take the floor at any time during the meeting, at the invitation of the Chair.

Announcement

 2021 Annual Meeting location: It was announced that the 2021 meeting will be held in Montreal, Canada. Further information will follow in due course.

AGM administrative session

After consideration regarding agenda items under the AGM administrative session, the General Assembly:

- Adopted unanimously the minutes of the 2019 annual meeting in Sydney.
- Recommended unanimously to the Board of Directors the approval of the 2019 annual accounts.
- Approved unanimously the 2020 proposed budget.
- Acknowledged that no increase of the membership fee would occur in 2021.
- Elected the following persons as members of the Board of Directors for a period of two years:
 - Michelle Stout, Chair,
 - Steve Mister, Vice Chair,
 - Gerhard Gans, Treasurer.

Each person elected previously held the same post, and so was effectively re-elected.
